One-story, cross-gabled frame dwelling. Metal roof with corbeled brick chimneys in east-west roof ridge and in west roof slope; decorative trim on gable edge. Walls are clad in shiplap siding and trimmed with cornerboards and friezeboard. Hipped porch wraps around façade and south elevation; has square columns with square feature near top. Centered entrance has a transom, paneled and glazed door, and screen door. Windows are 1-over-1 and 2-over-2 double hungs. Recent half-hipped bay window on south gable wall. Gabled entry porch on rear. Second entrance, east-facing, in southeast ell. Concrete foundation covered in wide board.

One-story, side-gabled log building. Metal roof, gable end clad in vertical boards. Entrance on south elevation has solid board door. Woodframe slider window.

Carriage house, circa 1902

One-story, gabled-L frame building. Metal roof, vertical board siding. Swing out doors and gable end windows in south gable wall; entrance with paneled door in southeast ell. Shed-roofed projection on east gable wall.

James W. Chamberlain was an early owner of vacant lots at this location. Chamberlain acquired Lots 9-16, Block 72, from Lake City Town Company in January, 1876, and immediately proceeded to sell lots to individual owners. Lot 11, the location of 111 Silver, was sold to S.W. Coleman who was assessed for \$450 in improvements on the lot in 1877. A circa 1878 Barnhouse & Wheeler stereoscopic view taken from the extreme south end of Silver Street depicts a front-gabled frame house on Lot 11 with a sign which appears to market the sale or repair of boots and shoes. Owners of the property subsequent to Coleman were former slaves Clark and Louisa Thompson, John "Black Jack" Howard, and George S. Lee.

Lee is primarily known as a promoter of Capitol City at the Forks of Henson Creek, the location of the fabled Lee Mansion which he built in 1879. Although the majority of his business interests were located at Capitol City, Lee did operate a lumber yard at the corner of Silver and First streets which in June, 1881, advertised ordinary lumber at \$30 per thousand and "kiln dried, perfectly clear lumber, \$35." The June, 1880, Federal Census for Lake City, lists both John Howard, a 35-year-old carpenter, and George S. Lee, his wife, Mary Jane, and daughter, 10-year old Rose, living in this south Silver Street neighborhood.

Lot 11 was transferred from John Howard to Rosa Lee in June, 1881. Failure of the Denver & Rio Grande to complete its route up the Lake Fork to Lake City caused a collapse of George Lee's financial fortunes, with the bulk of his Capitol City properties lost to creditors. Mirroring the family's other land holdings, Lot 11, Block 72, was sold through tax sale to Jacob J. Frank in 1889. Frank operated an adjoining blacksmith shop on the corner of Block 72.

The most significant changes to 111 Silver occurred late in 1891 and early the following year after J.J. Frank sold Lot 11 and building to Carrie Eisenkramer, wife of businessman Phil Eisenkramer. Eisenkramer (1863-1955) was owner of the Parlor Meat Market in Lake City and also worked as a butcher for the retail grocery firm Bigelow Bros., Coburn & Phillips. Phil Eisenkramer and his brother, Joseph Eisenkramer, followed their mother and step-father, William Vogel, from St. Louis, Missouri, to Lake City in 1883. The boys supposedly sold small statues of Jesus en route to fund their journey. After leaving Lake City in 1904, Phil and Carrie Eisenkramer relocated to Paonia, Colorado. He died in Pueblo,

Colorado, in 1955.

Phil Eisenkramer's remodel of the former Jacob Frank residence began in late November, 1891, when it was announced he intended to have the building repaired and enlarged with an addition. Lake City TIMES, March 24, 1892, reports Eisenkramer's "new residence on south Silver Street is towering up in great shape and, when complete, will make a very neat home." The completed single-story residence, as illustrated on the October, 1902, San born Insurance Map, consisted of a gable-facing clapboard house with distinctive wrap-around porch on the front and south elevations, all extant today.

Eisenkramer sold the house to R.R. Rosson in 1915 and it was used as a rental by John and Marie Atkins. Mr. Atkins was a former Ute-Ulay Mine master mechanic. In explaining his move to the Eisenkramer house in October, 1918, Atkins told the Lake City TIMES "he wants to go where he can mingle more generally with his fellow beings during the snow period." Later owners of the property were William and Nellie Nolan, A.P. Griffiths, Hal Whitton, and Bill and Judy Jordan prior to the current owner, Henry W. Woods. The house was elevated and a new foundation installed in 1984, together with gabled additions to the north (replacing a small bathroom addition) and west.

Back buildings at 111 Silver include a frame workshop on the alley and late 19th Century log cabin with gable roof. According to Woods, the cabin was originally located adjacent to the rear of the house on Lot 11 but was shifted to the north, Lot 10, during renovation of the house in 1984.
