Historical background: Businessman Mike Pavich, owner of the Hough Block, 304 and 300 Silver, and Watson Shoe Building. 308 Silver, utilized a vacant lot located between the two structures to construct this brick commercial building around 1950. As a continuation of Lake City builders' historic use of reused building materials. Pavich utilized brick which he salvaged from the C.H. Blakeslee Mill at the Gallic-Vulcan Mine, located on North Henson Creek above Capitol City, which he transported from the mill to Lake City and used to build the front and back walls of the new commercial building. For the decade following its construction, 306 Silver was operated in conjunction with the building to its immediate north, the historic Watson Shoe Building, 308 Silver. The two buildings were leased by Canon City, Colorado, businessman Roy Pray in June, 1951, for use as the Lone Star Cafe and Bar. Pray is best known as the original owner and builder of the Crystal Lodge, located south of Lake City near Silver Coin Gulch, which he opened in May, 1952. Mike Pavich's sons, Larry Pavich and Mickey Pavich. continued the Lone Star Cafe and Bar at 306 and 308 Silver from 1952 through 1954, and were succeeded in 1955 by Jim and Therese Ryan. Mrs. Ryan recalls that a favorite staple at the cafe the summer of 1955 was rainbow sherbet; another vivid memory from that summer was the regular summer chore of washing blood and debris from the sidewalk outside the bar, the result of fights which took place in the early morning hours. The Ryans left the buildings in 1957 when their business expanded to the Elkhorn Lodge in the old First National Bank Building. The Ryans were followed at 306 and 308 Silver by Mr. and Mrs. W.A. Muncy who opened Lake City Sportsman, a combined sporting goods and laundromat business which continued through 1960. From 1970 to 1975 the building was used by Irene Thompson as "Irene's Beauty Parlor." The Pavich Building, together with other Pavich-owned businesses on Silver Street, including the Hough Block, was sold to John Parker in 1976. 306 Silver continued as a government office and information center leased by U.S. Forest Service and Hinsdale County Chamber of Commerce from 1976 until 2000. It has contained the Lone Star Bar and Café, a sporting supply store, laundromat, and Chamber of Commerce office. Assessment of historic physical integrity to significance:
