In addition to his duties at Hinsdale County Treasurer, William F. "Billy" Green was an inveterate tinkerer and early automobile enthusiast. He traveled to Denver in 1916 to purchase an automobile and returned with a "Metz." The auto, relatively unknown even at that date, had a large metal disc which was turned by the engine. To drive the car, it was necessary to press a fiber-covered wheel against the disc, the resulting friction propelling the vehicle. According to Green's son, David, the Metz's top speed was about 20 miles per hour, "although it really shined doing down hill." Green's stock of automobiles was increased in 1922 with the addition of a Willys Knight and Hupmobile.

As an offshoot of his early enthusiasm for automobiles, Billy Green discovered he needed a garage to store and maintain his new-fangled driving machine. In 1917 he contracted with the Hunt brothers, well known brick masons, to construct a garage building on the rear of his lots adjoining the Green residence, 401 Gunnison. The ground floor of the garage was designed to hold two automobiles, together with grease pit and other garage equipment. One of Green's first tasks was using the garage to rebore the Metz's cylinders and add pistons in an attempt to increase the engine's efficiency. A partial second story was added to the front of the garage, furnishing Green a much-needed office accessed by a steep set of stairs which led up from the garage.

The upstairs portion of the garage was extended back the full length of the garage in 1918. "W.F. Green is having difficulties by the unfriendliness of the weather in getting the second story of his brick garage finished, the Lake City SILVER WORLD wrote in November, 1918, "but when completed it is now plain that it will be a decided improvement to the perspective of Fourth Street." The Greens realized the mistake of having a flat roof on the garage, according to David Green, and in later years spent many winters shoveling snow off the roof. Billy Green utilized his enlarged upstairs office to mirror his versatile interests, including darkroom for photography and assay office in conjunction with his Gold Quartz Mining & Milling Co. Green's garage remained relatively intact following his death in 1950 and was at last emptied during garage-cleaning efforts in the 1960s. Several of Green's 1920s'era automobiles were taken from the garage and sold at that time.

James and Dot Main acquired the Green family property, including two-story brick garage, in 1972. The garage building was expanded with a 20' two-story brick addition in 1982 as part of the Mains' continuing business. Slumgullion Gift Gallery, which occupies the building. Exterior inspection of the building provides clues to its evolution, slightly different-hued bricks highlighting the dimensions of the original

ground-floor garage and the first portion of the upstairs office. Bricks of a slightly different color denote the expansion of the upstairs in 1918, together with the 1982 rear addition.
