General architectural description:

Two-story, side-gabled frame building. Metal roof has "Matterhorn Motel" neon sign mounted on roof ridge. Walls are clad in asbestos shingles with fish scale shingles on lower wall of first story. Façade has gabled balcony-porch with shingled gable end and plain wooden balusters. Balcony entrance is centered, contains paneled door; entrance in first story is off-center with a paneled door. Windows are large sliders - woodframe on first story and metalframe on second story.

Small, one-story, gabled section on southwest comer with walls clad in asbestos-shingle. West elevation has a gabled, second-story entry porch accessed by wood stairs and sheltering a paneled door. Concrete foundation.

3446 square feet.

Long, narrow, one-story, side-gabled section contains 12 motel units. Walls are clad in asbestos shingles. Six gabled entry porches have turned wood posts and gable ends covered in fish scale shingles. Each porch shelters two entrances, each with a paneled door. Each unit has a metal-frame slider window. Windows and doors have 1997 triangular pediment. Concrete foundation.

Unit 13, circa 1910

412.5 square feet

One-story, hipped-roof frame dwelling with metal roof. Walls are clad in shiplap siding. Half-hipped porch is supported by logs. Centered entrance has paneled door and screen door, flanked by 9-lite windows. Second entrance on north elevation has shed-roofed stoop cover above an entrance with a paneled and glazed door and a screen door. Concrete foundation. Moved to this location in 1993 from the Iron Kettle cabins at 201 Gunnison Avenue.

Unit 14, circa 1935

400 square feet

Side-gabled frame dwelling with metal roof. Walls clad in shiplap siding. Concrete foundation. Shed-roofed porch has square wood posts, shelters a window and an off-center entrance with solid door. Moved to this location in 1993 from the Iron Kettle cabins at 201 Gunnison Avenue.

- Historical background:

George Edwards (1901-1981) and other newly arrived post-World War II businessmen took part in what was referred to as the "Revolt of the 1940s" in which long-time Lake City local residents were displaced by new investors. Edwards consolidated a series of lots in Casco Addition on the west side of Bluff Street between Fourth and Fifth streets, and in early 1949 began construction of the 18-unit Matterhorn Motel. Work on the business progressed rapidly and it opened on July 1, 1949.

The property consisted of a two-story building with two-story balcony on the south end containing office and motel rooms which were rented at \$5 per day, with daily maid service. The adjacent single-story tourist court units, each sharing a gabled porch entrance, included bedroom and kitchenettes renting for \$7.50 for four people, although maid service was not provided. Innovative features in the tourist apartments included Armstrong Tile floors, propane wall heaters, private showers and baths, flush toilets, and hot and cold running water. All units were advertised as "fire-proof" and the kitchenettes boasted such rare Lake City amenities as electric refrigerators and propane cook stoves, together with steel venetian blinds, metal dinette sets, and light wood furniture in western motif. Although pets were not allowed, advertising for the motel stressed it was located a mere two blocks from the center of Lake City

and within easy walking distance of fishing streams.

George Edwards at first favored demolishing the neighboring Baptist Church to provide additional room for his motel, but later changed his mind and paid off the mortgage on the church building in return for permission to use the building to project movies for his guests two evenings a week.

In addition to operating the Matterhorn Motel, George Edwards served at different times as chairman of the Hinsdale County Board of Commissioners and Mayor of Lake City, and was chairman of the newly formed Hinsdale County Chamber of Commerce in 1951. He and other businessmen convinced the state to pave State Highway 149 between Gunnison and Lake City, and induced the Rural Electric Association to furnish a dependable source of power by building electric lines up the Lake Fork Valley to Lake City.

Edwards sold the Matterhorn Motel in 1958; subsequent owners were Doyle Baumberger, Melvin Schell, and Bennie Jacobs. Bill St. James acquired the property in 1997 and completed a thorough renovation, including the addition of turned porch columns and decorative wooden shingles, prior to sale of the property to the current owners, David and Karen Mourhess, in 2000. The roof of the two-story owners/office unit of the motel is the base for a free-standing metal sign with letters outlining the words "MATTERHORN MOTEL" dating from circa 1950.

Units 13 and 14, at the north end of the Matterhorn Motel, were moved to the site in 1993 from the Iron Kettle Cabins, 201 Gunnison Avenues. These two cabins were located on the rear of the Iron Kettle lots and dated to the 1930s when they were part of the a tourist rental court known as Grandon Cabins. Unit 14 is a 1930s-era cabin built for the Grandon resort by Vernie Ramsey. Unit 13, also from the old Grandon Cabins, is of older vintage and dates to perhaps 1900 when it was occupied by Lake City midwife Sarah (McGaffin) Madison.
