One-story, front-gabled frame dwelling. Metal roof with flush skylight in south slope. Walls clad in clapboards and trimmed in friezeboard and cornerboards with square capitals. Windows have bracketed hoods; are covered in shutters. Façade has centered entrance with transom, tri-lite paneled door, and screen door.

Entrance is topped by half-hipped entry cover supported by elaborate carved brackets. Small 2-lite window in façade gable end has a bracketed hood. Façade has full-width, small, open-roof porch with low baluster and finial posts, accessed by short boardwalk. Gabled section at rear has a shed-roofed addition on the south.

King was reported to be building this "cozy Cottage" on Silver Street below Fifth Street in May, 1882. The reported cost of the King cottage was \$700. King was a local businessman who advanced in local law enforcement circles as a result of the promotion of Clair Smith. Smith was named

Street in May, 1882. The reported cost of the King cottage was \$700. King was a local businessman who advanced in local law enforcement circles as a result of the promotion of Clair Smith. Smith was named Hinsdale County Sheriff in April, 1882, following the shooting death of Sheriff Edward N. Campbell and King was selected to replace Smith as Lake City Marshal. King was named Hinsdale County Undersheriff in 1884 when Sheriff Smith absconded with fees collected by the sheriff's department. In addition to his local law enforcement career, John King held positions in Silver Star Lodge No. 27, IOOF, and the J.S. Hough Fire Company; he is listed as a collection and real estate agent in 1884. He lost his business during the local economic downturn in the mid-1880s and his house at 510 Silver Street was repossessed by local banker Henry Derst in 1886. The house was used as a rental prior to 1889 when it was sold by Derst for \$650 to John and Emma Swanson.

John Swanson was a native of Sweden who served in the Confederate Navy during the Civil War. He worked his way west through Sheridan, Kansas, and Kit Carson, Colorado, and in 1874 conducted the Summit House hotel and saloon in Del Norte, Colorado. He followed mining after relocating to Lake City in 1876. He married Mrs. Emma Strom in Lake City in 1888; Mrs. Strom's husband, John Strom died in a snowslide at the Vermont Mine on Henson Creek in January, 1887. Mrs. Swanson leased the Pueblo House hotel following John Swanson's death in 1891; she continued to live in the lower Silver Street house until moving to Colorado Springs, Colorado, where she died in 1904. Subsequent owners of 510 Silver Street were W.C. and Anna (Maurer) Blair, who purchased the house in 1902; Mr. Blair was a well known Lake City journalist who owned and edited Lake City weekly newspapers from 1900 to 1938. In 1914 the house was sold to retired Hinsdale County Sheriff William P. Hunt and his wife, Lucy. Current owners of the house and single lot are Ruth Glass and Janet Galbiati, Arlington, Texas


