- General architectural description:

1-1/2 and one-story gabled-L frame dwelling. Corrugated metal roof with corbeled brick chimney in roof ridge. Walls clad in clapboards and trimmed in cornerboards; gable ends are clad in fish scale shingles. Small four-lite in north gable end; small octagonal window in east gable end; small flush skylight near roof ridge. The bay window in the gable wall has 4-over-4 double hung windows with metal storms; bracketed crowns have scrolled brackets.

Shed-roofed addition in northeast ell. Circa 1968, front-gabled entry porch supported by turned posts, has spindle brackets and porch frieze. One-story gabled addition on north has exposed rafters; clad in lapped siding. Stone and concrete foundation.

Historical background: Charles Kayser, a real estate speculator who owned an impressive list of Lake City property in the early 1880s, was assessed for a house at this site valued at \$300 in 1881. Kayser transferred his ownership of the house with Lots 8 and 9, Block 40, to yet another local speculator, Leon LeFevre, in the 1880s, It is unclear whether LeFevre actually lived in the house or used it as a rental property, although newspaper notations indicate the residence was the home of Prof. J.C. Logan in 1892, Rev. C.A. Parker in 1893, and Frank and Elizabeth Swank in 1911. LeFevre operated a slaughter house in Las Animas, Colorado, in 1874 but shortly afterward relocated to Lake City where his initial business interests were a livery stable and butcher shop. By the 1880s he amassed a fortune in local real estate, including both residential and business property, but was considered a miserly recluse. He died in Denver in 1912, leaving a fortune in excess of \$75,000. The Lake City TIMES noted "LeFevre is well known to the people of this town and county, and for them to believe that he ever gave away anything would be a great tax upon their credulity." According to tax records, the value of the LeFevre house had declined to \$100 by 1920, the year in which the property was transferred from the LeFevre Estate to Levi C. Carman.

Levi C. Carman (1893-1933) and his brother, Henry A. Carman (1889-1963) were sons of Rueben and Anna Carman who moved to Lake City from Douglas County, Colorado, in 1892. Mrs. Carman was widowed in 1899 and in 1900 moved her family to a small frame house (valuation \$80 1900) at 519 Silver Street (located between LeFevre-Carman House, 517 Silver, and Murphy Kirker House, 521 Silver) which was demolished by Henry Carman in October, 1941. Brothers Levi Carman and Henry Carman were well known carpenters and miners of the Lake City area. They made their home in the LeFevre House, 517 Silver, for the remainder of their lives and cared for their widowed mother in the home prior to her death in 1933.

Following Henry Carman's death, the home was sold to James and M. Therese Ryan, owners of the Elkhorn in the First National Bank Block, in 1966. At this time the home consisted of the living room with bay window, kitchen, and a narrow bedroom. The Ryans constructed the living room addition to the north and spindlework porch c. 1968. Current owners Cap and Violet Davis contracted for a fireplace at the north end of the new addition, as well as finish work in the interior of the gable end of the original house.


Back buildings at the LeFevre-Carman House consist of an enclosed wooden storage building with shed roof and single-car corrugated metal garage with gable roof, double doors opening onto the alley.

It is well-preserved representative of the local interpretation of the Italianate style constructed in Lake City during this period, as reflected in its clapboard exterior, porch brackets, narrow windows, and triangular window heads.

	Although slightly altered by addition of a 1968 front porch, this dwelling retains its architectural integrity - size, scale, roof form, clapboard materials and decorative features.
