One- and 1-1/2 story front-gabled frame dwelling clad in clapboards and trimmed with cornerboards. Roofed in corrugated metal; brick chimney in roof ridge. Top of gable end is clad in fish scale shingles. Gabled entry porch has turned posts, decorative brackets, and fish scale shingles in the gable end. It shelters a glazed and paneled door with paired, round-arched panels, and screen door with a bracketed crown. Gable wall has paired 1-over-1 double hung windows with bracketed hoods with scrolled brackets. Other windows are also 1over-1 double hung. Gabled addition on rear. Foundation is not visible.

Historical background: This single story frame house first shows up in 1890 tax rolls as a \$300 improvement on land owned by Ella C. Murphy. Mrs. Murphy and her husband, John L. Murphy, acquired the vacant land from Leon Lefevre the previous year for \$150. Mr. Murphy was a butcher who operated shops in Lake City beginning in 1882, associating himself at different times with such well known meat dealers as Albert Greenfield, F.M. Mendenhall, J.J. Pride, and W.S. Whinnery. In 1884 J.L. Murphy & Co. advertised "fresh and salt meats, vegetables, etc." at their store on Third Street.

A house fire in December, 1893, gutted both the James L. Ray house (525 Silver Street) and the adjoining Ella C. Murphy house, 521 Silver Street. Firemen worked to save the houses, which were separated by a narrow 6" gap. According to the Lake City TIMES, the Murphy house "soon caught fire and the building was almost entirely destroyed, but not until after all the furniture was removed. On account of the deep snow the hose companies were slow in getting to the fire, and when the boys arrived

they were about played out from running and the hard pull through the snow."

The Murphy house, though gutted by the fire, remained standing and in March, 1894, its shell was sold to builder J.H. Rhoads who renovated the structure and sold it to Josiah S. Kirker for \$326 on January 2, 1895. A native of Ohio, J.S. Kirker (1859-1898) followed prospecting after coming to Lake City with his father and brothers in 1876. Unable to continue work after developing miners' consumption, he was elected Hinsdale County Clerk & Recorder. He died in May, 1898.

Kirker's widow remarried and in 1909 sold the house for \$410 to Katie Ewart. Mrs. Ewart was a native of Denmark who married mine cook Rowland W. Ewart in Lake City in 1901. Mr. Ewart died during the influenza epidemic in 1920 and Katie Ewart continued to live in the Silver Street home where, as a widow, she raised two sons and five daughters. The property was acquired by Clarence E. Wright after William Ewart moved his mother into the neighboring Thompson-Whinnery House, 513 Silver Street. The house's current owner is Mary Belle May of Alexandria, Louisiana.

A c.1920 coal shed with exposed 2x4 timber framing is located on the alley behind the Murphy-Kirker house


