- 35. Historical background:

Harry Youmans, owner of the Lake City planing mill, owned a single-story house at this location which burned to the ground in December, 1896. The corner lots remained vacant until 1900 when Youmans was assessed for improvements valued at \$150. Albert G. Wood, owner of the Last Chance Livery in Lake City and Monarch Livery, Salida, Colorado, owned the cabin from 1902 until 1922, other owners including J.N. McCloughan, Leonard Merrill, and Marguerite Foster. Alex Carey (1908-1963), who was born and raised across the street in the Youmans-Carey House, 600 Gunnison, paid \$75 for the cabin and two lots in November, 1936. Carey's first tasks after acquiring the cabin were building an interior floor to replace the cabin's dirt floor, and, on the exterior, covering the logs with clapboard. It was the honeymoon home of Alex Carey's brother and his wife, Malcolm and Drucilla (Buntin) Carey, and remains the seasonal home of Malcolm Carey's daughter, Margaret Carey Kimball, in 2003.


The gable-front house has a gabled entry porch with scallop trim and a small south-facing gable bathroom addition. A native rock fireplace c. 1936 is located on the cabin's north wall, and two additions at the rear -- one gabled and the other a shed roof, with a combination of shingles and board and batten in the east-facing gable ends. The property also includes a well house and open-sided car port, both with scallop trim, and a c. 1975 gable-facing garage adjoining the alley.

42.	2. Statement of significance: This house is associated with settlement and development of Lake City during the late 1800s mining era. It is a well-preserved representative of the vernacular dwellings constructed in Lake City during this period, as reflected in its simple design, log construction, lapped wood siding, gabled roof, entry porch, 2-over-2 double hung windows, and lack of architectural details that indicate a particular style. The carriage house/garage and shed located at the rear of the lot near the alley are also associated with settlement and development of Lake City. They are representative of the outbuildings constructed in Lake City in the late 1800s and early 1900s as reflected in their alley location, frame construction, and wood siding. The house is also associated with recreation and tourism, having become a summer dwelling in the late		
	1930s. The alterations in 1936 are typical of those made to mining-era cabins to improve them for use as summer residences.
