- 35. Historical background:

German immigrants have historically been associated with this front-gabled house which is constructed of abode bricks with stucco covering. The house adjoins vacant lots to the north which were used as a small truck farm where vegetables such as potatoes were raised for sale in Lake City. Earlier owners of the land included well known toll road builder and promoter Otto Mears, as well as William Robert Monteith who served as deputy sheriff and town marshal in Lake City in 1875 and 1876. Monteith owned a house at this location which was valued at \$400 in 1877, although it is no longer extant.

The existing abode with stucco house is apparently of later date and first shows up as an improvement on Hinsdale County Tax Rolls in 1897, valued at \$100 for tax purposes and assessed to Anna Crawford Vogel and her husband, William Vogel. Mr. Vogel was a native of Dattenfeld, Germany, who came to Lake City via St. Louis, Missouri, around 1877 and worked as a blacksmith. He died at Paonia, Colorado, in December, 1914. The Vogel house was sold to members of the Jensen family in 1910.

The existing adobe brick house is most closely associated the Jensen family, three brothers from Bordelum, Schlesing Holstein Province, Germany, who moved to Lake City between 1904 and 1910. Two of the brothers, Johann Peter Jensen (1857-1916) and Nicoli Jensen (1863-1911) acquired cattle ranches in the Lake Fork Valley above and below Lake City, while the third brother, Broder Ludwig Jensen (1857-1944) assisted his brothers and lived in the adobe house at 615 Silver Street from around 1915 until his death.

The residence also served as a home for Jensen's nephew, Nis Hansen (1883-1940), who operated a second hand and scrap metal business. Photographs from the 1920s show the perimeter fence encircling the house and its well-tended vegetable gardens. The house remained vacant following Broder Jensen's death, although it wasn't until the 1980s that the property was sold to Terry McGehee and Sheila Hunt, the current owners. A new stucco coating was applied over the adobe bricks in 2001

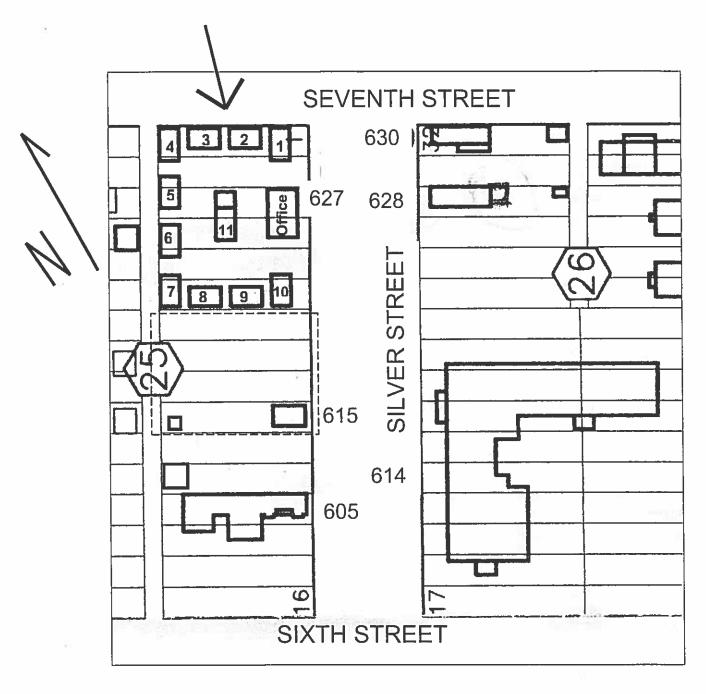

It is one of the few adobe buildings remaining within the Lake City Historic District.
